The Teton County Board of Commissioners met in regular meeting on **August 8, 2022** in the Commissioners Chambers located at 200 S. Willow in Jackson. The meeting was called to order at 9:02 a.m.

The Board discussed their availability to attend a meeting with Teton County, Idaho, to hear updates on an Economic Impact Report.

A. WYDOT Construction Staging

WYDOT recently raised the possibility of housing temporary workers for the Hwy. 22/390 State Highway Project on the Stilson Park owned by Teton County. That parcel is currently zoned as Park (P) and does not allow for temporary worker housing. A text amendment to the Park Zone would be necessary to allow for the use of temporary worker housing. The Board discussed sharing with WYDOT the County's process of amending allowed uses in a Park (P) Zone with a CUP so that WYDOT can understand the process and resulting timeline for Construction projects.

B. West Coast Consulting (WC-3) Contract for Plan Reviews

Chris Neubecker, Director of Planning and Building Services, presented to the Board for discussion the need to continue contracting WC-3 for building permit reviews. Building permits are being turned around on average by 11.5 days by WC-3. There was consensus to continue with the current contract.
