LVE is building a new employee housing development on South Hwy 89 on the eastern side of the highway across from Melody Ranch Subdivision. LVE is connecting to the main sewer through Melody Ranch Subdivision. In order to get from the proposed new subdivision to the connection in Melody Ranch Subdivision, the sewer line will need to cross through Melody Park which is owned by Teton County and sits at the intersection of South Park Loop Road South and State Hwy. 89. An appraisal was obtained and LVE has paid the county the appraised amount of \$1890.00.

A motion was made by Commissioner Macker and seconded by Commissioner Newcomb to approve the sewer line easement to Lower Valley Electric to allow LVE to connect their new subdivision on South Highway 89 to the sewer system. Chair Propst called for a vote. The vote showed all in favor and the motion carried.

Location: 1455 N Beckley Park Way, or Lots 1 & 3 of Stilson Park, are located at the

northwest corner of the intersection of State Highway 22 and Moose-Wilson Road (State Highway 390). Lot 1 is zoned Rural-2 and Lot 3 is zoned Public/Semi-Public. Both lots are in the Scenic Resources Overlay and partially in the Natural

Resources Overlay.

The purpose of these two applications is to create a lot within the Stilson Park Subdivision which will be conveyed to Teton County, Wyoming as an element of the Federal BUILD Grant that was obtained to assist Teton County with the Stilson Transit Center/Park-n-Ride, which is the largest of the 13 component projects of the Teton Mobility Corridor Improvements (TMCI) being funded by the grant. The transfer of this land from the Jackson Hole Mountain Resort (JHMR) to Teton County is a necessary part of securing the \$25 million Federal B.U.I.L.D. Grant funds as a local match requirement.

There was no public comment.

MOTION FOR EXD2023-0003

A motion was made by Commissioner Epstein and seconded by Commissioner Newcomb to approve EXD2023-0003, updated June 16, 2023 for the exempt land division to create one lot for the Teton County Transit Center and one lot for the wireless telecommunication facility, with two conditions, based on the recommended findings:

- Concurrent with the recording of the final plat, an instrument acceptable to the Planning Director that limits the use of the property to unmanned communication facilities, compressor stations, metering stations, fiber optic booster stations, or similar unmanned facilities shall be recorded with the Teton County Clerk against Lot 5.
- Concurrent with the recording of the final plat, a warranty deed shall be filed with the Teton County Clerk which conveys the ownership of Lot 7 to Teton County, Wyoming.

Chair Propst called for a vote. The vote showed all in favor and the motion carried

MOTION FOR BDJ2023-0001

A motion was made by Commissioner Epstein and seconded by Commissioner Gardner to approve BDJ2023-0001, updated June 16, 2023 to adjust lot lines between Lots 1 & 3 of the Stilson Park Subdivision, with one condition, based on the recommended findings, and request that the Teton County Clerk write "Vacate" on Lots 1 and 3 of Plat No. 911 upon the filing of the amended plat.

1. All easement documents referenced on the final plat shall be signed and recorded in the Teton County Clerk records concurrent with the Subdivision plat.

Chair Propst called for a vote. The vote showed all in favor and the motion carried.

conforming mobile home use.

Location: 10755 S Highway 89 is Lots 8-12 of the Rogers Point Subdivision in Hoback

Junction. The property is on the east bank of the Snake River, is zoned Auto-

Urban Commercial and is in the Natural Resources Overlay.

Chandler Windom, Senior Planner, presented to the Board for consideration of approval a Conditional Use Permit (CUP2022-0007) pursuant to Section 8.4.2 and 1.9.3.C of the Teton County Land Development Regulations (LDRs) for a mobile home use.

The request is for a change of use from a non-conforming campground use to non-conforming mobile homes on the site commonly referred to as the Hoback RV Park. This change of use is in addition to the recently approved ministorage warehouses (DEV2022-0007/CUP2022-0006) and 4 accessory residential units (ARUs). The original application proposed 13 mobile home units on the site. In response to comments from the Plan Review Committee (PRC) the applicant has reduced the request to 9 mobile home units.

Amy Ramage, County Engineer, presented a Small Wastewater Facility variance request that will be presented for approval at a later date. Even if it is approved, the Conditional Use Permit will not be issued until the SWF is approved (see condition 6).

Tyler Davis, Applicant, and Matt Bowers, Nelson Engineering, commented on the application.

Public comment was given by Tammy Wooster, Kevin Reagan, via Zoom, Kevin Krasnow with Jackson Hole Conservation Alliance and Shila Wruck.

Matt Bowers gave details regarding high-nitrate readings.

The meeting recessed at 11:54 a.m. and reconvened at 1:30 p.m. and this matter from Planning was continued to after the afternoon workshop.

Location: 10755 S Highway 89 is Lots 8-12 of the Rogers Point Subdivision in Hoback

Junction. The property is on the east bank of the Snake River, is zoned Auto-

Urban Commercial and is in the Natural Resources Overlay.

Chandler Windom summarized the updated language for recommended conditions of approval.

A motion was made by Commissioner Newcomb and seconded by Commissioner Epstein to approve CUP2022-0007 revised April 25, 2023, for the proposed Mobile Home Use, with the following conditions, based on the findings recommended below:

- 1. A maximum of 9 one-bedroom mobile homes are permitted.
- 2. The future mobile homes shall demonstrate compliance with the minimum roof pitch of 3 in 12.
- 3. A 10-foot minimum setback from the western property line shall be maintained for all mobile homes and site development.
- 4. A total of 23 parking spaces are required on the site. Additional parking spaces shall be installed prior to occupancy of the associated mobile home units.
- 5. Prior to mobile home occupancy, a minimum of 7 plant units shall be installed.
- 6. This permit shall not be issued unless the associated Small Wastewater Facility (SWF) permit with variance request, SWF2023-0066, is approved. All conditions of SWF2023-0066, if approved shall be met to continue the use approved by this permit.

7. Annual water quality and small wastewater facility monitoring as outlined in SWF 2023-0066 is required, and reports shall be submitted to the County engineer with results by June 30th of each calendar year.

Planning Director Neubecker suggested a friendly amendment to the motion to specify that "this permit" in condition 6 refers to CUP2022-0007.

Commissioner Newcomb amended his motion to clarify that "This permit" refers to this conditional use permit; CUP2022-0007, and Commissioner Epstein seconded the amendment.

Chair Propst called for a vote on the amended motion. The vote showed all in favor and the motion carried.

OTHER MATTERS FROM COMMISSION
