**Subject:** Concurrence Letter to WYDOT for Cattleman’s Bridge – Structure #DEK

**Statement / Purpose:** *Consideration of a Letter of Concurrence to Wyoming Department of Transportation for the replacement of Structure #DEK over the Gros Ventre River, also known as Cattleman’s Bridge.*

**Background / Description (Pros & Cons):** *In 2005, Teton County entered into a cooperative agreement with WYDOT through a federal program called Bridge Replacement Off System (BROS). This program provides an 80% match to local jurisdictions for bridge design and a 90% match for construction. In 2009, Teton County asked to withdraw from this program and then subsequently requested WYDOT re-start the project in 2011. Based on Amendment #1 to the original cooperative agreement, approved by the BCC on October 9, 2017, our required match is 9.51% of the total BROS project cost.*

*On October 12, 2017, WYDOT opened bids for this project. The apparent low bidder is [REDACTED], with a bid of \$XXXXXXXXXX. Based on this bid, Teton County’s obligation for the 9.51% share of the bridge replacement is \$XXXXXXXXXX.*

**Stakeholder Analysis & Involvement:** *Teton County Public Works staff have worked with adjacent property owners and coordinated with WYDOT.*

**Fiscal Impact:** *Baring significant change orders, the total fiscal impact to Teton County for Cattleman’s Bridge replacement is \$XXXXXXXXXX. Beyond the actual bridge replacement costs, and outside the BROS program, the County will have additional expenses for County-required environmental mitigation.*

**Staff Impact:** *Minimal*

**Staff Input / Recommendation:** *Staff has reviewed Exhibit B and the estimated County cost share and recommend approval of the Letter of Concurrence to the Wyoming Transportation Commission.*
