Subject: Spring Clean-Up Week

Statement / Purpose:

Representatives and organizations that have collaborated on the Jackson Hole Community Spring Clean-Up have requested that the Teton County Board of Commissioners formally proclaim May 7th to May 12th, 2018 as Spring Clean-Up Week and Saturday, May 12th, 2018 as Spring Clean-Up Day.

Background / Description (Pros & Cons):

The Jackson Hole Community Spring Clean-Up has been an annual tradition in the community since 1969. Jackson Hole's three Rotary Clubs assumed primary responsibility for coordinating efforts related to this community event in 2006. In keeping with the value of ecosystem stewardship and practices of sustainability, Teton County has supported these efforts over the years in varying capacities.

Stakeholder Analysis & Involvement:

Representatives involved in the organizing of this year's event contacted Teton County Commissioners and staff to formally request that the Board of Commissioners formally proclaim Spring Clean-Up Week (5/7/18 – 5/12/18) and Spring Clean-Up Day (5/12/18) in Teton County. In addition, organizers have worked with Integrated Solid Waste and Recycling (ISWR) to coordinate extended hours and reduced rates at the Transfer Station to encourage increased participation and volunteerism related to refuse collection and yard waste disposal.

Fiscal Impact:

Spring Clean-Up Day volunteers will be admitted to the Transfer Station free of charge to dispose of refuse collected on area highways and roads, and the tip fee of \$80/ton for compostable yard waste will be waived from 5/7/18 to 5/12/18 for residential customers. This will result in decreased revenues for the Transfer Station during this period of time.

Staff Impact:

Extended hours at the Transfer Station (Mon-Fri, 8:00am-5:00pm, Saturday, 9:00am-5:00pm) will require additional staff resources.

RESOLUTION PROCLAIMING MAY 7th to May 12th, 2018, AS SPRING CLEAN-UP WEEK, AND SATURDAY, MAY 12, 2018, AS SPRING CLEAN-UP DAY

WHEREAS, the Rotary Club of Jackson Hole is coordinating a community-wide Spring clean-up event;

WHEREAS, Teton County, Wyoming, has declared Spring Clean-Up Week and Spring Clean-Up Day annually since 1969; and

WHEREAS, community service clubs, organizations, businesses, individuals, the Town of Jackson, and Teton County Integrated Solid Waste and Recycling are collaborating to reduce landfill-bound waste, encourage ecological stewardship, and improve the appearance of the valley for both residents and visitors.

NOW THEREFORE, having duly met at a regular meeting on May 1, 2018, and having fully considered the matter, it is hereby,

RESOLVED, that the Teton County Board of Commissioners proclaims May 7 to May 12, 2018, as Spring Clean-Up Week and Saturday, May 12, 2018, as Spring Clean-Up Day in Teton County, Wyoming, and:

1. Spring Clean-Up Day volunteers who dispose of refuse collected along highways and roads will be admitted free of charge at the Transfer Station facility on Saturday, May 12, 2018;
2. During this week, the tip fee of \$80 per ton for compostable yard waste will be waived for residential customers;
3. The Transfer Station will offer extended hours during this week as follows: Monday – Friday, 8am-5pm; and, Saturday, 9am-5pm.
