WHEREAS, the Wyoming Alta Solid Waste Disposal District (the "District") was formed on March 21, 1995, by the Teton County Board of Commissioners pursuant to Wyoming State Statutes 18-11-101 seq.; and

WHEREAS, the Board of Directors of the District (the "Board") has determined that it is in the best interest of the public and the District to dissolve the District; and

WHEREAS, the Board has considered the fiscal and environmental impacts of such dissolution and has concluded that all obligations of the District can be satisfied in conjunction with the dissolution.

NOW, THEREFORE, BE IT RESOLVED, that the Board hereby initiates the process of dissolution of the Wyoming Alta Solid Waste Disposal District in accordance with the relevant provisions of the Wyoming State Statutes and any other applicable laws and regulations; and

BE IT FURTHER RESOLVED, that the Board shall take all necessary and appropriate actions to wind up the affairs of the District, including the satisfaction of all liabilities and obligations, the disposition of assets, and the completion of all required legal and administrative procedures.
