

## Health Department and Health Order Updates August 14, 2020

- 1) The 10<sup>th</sup> continuation of the State Health Orders will go into effect August 16, 2020 and shall remain in effect through August 31, 2020. Orders #1 and #3 remain the same. Order #2 has been modified to increase outdoor gathering limits. They will be available at: <https://www.jhcovid.com/>

- 4) In the past two weeks (7/31 to 8/13) there were 45 new cases reported.
  - 15 cases attributable to community spread (33%).
  - 27 cases had close contact with another known case (60%).
  - 7 cases had a history of travel (16%) – May be included in other 2 categories also.
