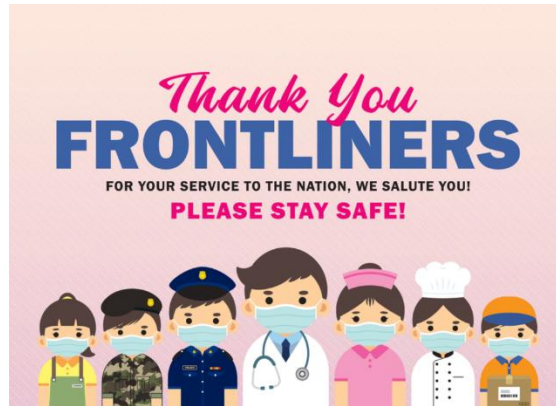


Health Department and Health Order Updates August 21, 2020



- 1) All-online CPO courses are now being offered through the Pool and Hot Tub Alliance. To find a course go to <https://www.nspf.org/course-locations>. Select "United States" and leave the "State/Province" and "City (Optional)" fields blank. Enter the desired date range and click apply to search. If the course is online this will be indicated under the column "City". Enrollees should verify with the CPO instructor that the course and exam is in a 100% online format.

- 7) In the past two weeks (8/7 to 8/20) there were 33 new cases reported.
 - 14 cases attributable to community spread (42%).
 - 16 cases had close contact with another known case (48%).
 - 6 cases had a history of travel (18%) – May be included in other 2 categories also.
