Year in Review

January 1, 2021 - December 31, 2021

2021



January

ISWR began the new year awarding Yellow Iron Excavating a 7-year contract for Trash Transfer Station operations and landfill hauling.



April

ISWR upgraded the current baler, which recycling operations rely on, increasing overall recycling efficiency and decreasing operating hours and labor costs.

February

ISWR announced the grand opening of the Food Waste Composting Facility and began accepting food waste. Over 11 tons of food waste have been collected and diverted from the landfill.



May

Teton County was interviewed by Green New World TV; a film showcasing national sustainability efforts and highlighting the people & places building a better, greener future.



March

ISWR identified missed reuse opportunities related to C&D waste and added a "dirty" dimensional wood pile at the Transfer Station. Another initiative included in the Road to Zero Waste plan.



June

In partnership with the University of Wyoming Haub School students, ISWR executed an Environmental Solutions study on propane and bear spray canister disposal alternatives.



Year in Review

July

In partnership with JH Public Art, ISWR hosted the Mountain Academy's recycled troll house.

In addition, Recycling Art Resident, Suzanne Morlock installed the public art piece "flores pulchros" in the Town Square, challenging the perception of waste culture.

October

In partnership with Recycle Coach, ISWR introduced a recycle app to Teton County. The new platform makes it easy for residents to get local disposal information and become better recyclers.



August

ISWR staff submitted the operating permit renewal application to Wyoming DEQ for Recycling Center and Household Hazardous Waste Collection Facilities. The application was approved in August for a lifetime.

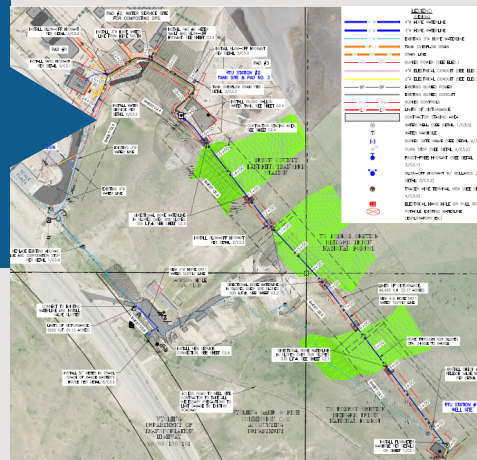


November

In 2021 ISWR collected and recycled 1,425 tons of scrap metal.

September

In partnership with Teton Conservation District, ISWR completed the Teton County Trash Transfer Station Water System Improvements project.



December

In partnership with Spring Back Utah, ISWR introduced a mattress recycling program; a new initiative on the Road to Zero Waste.



What does Zero Waste mean for Teton County?

Use of the phrase "Road to Zero Waste" is intended to emphasize that Teton County is working toward zero over time. Following the adoption of the Zero Waste Resolution, Teton County ISWR staff compiled a list of recommended strategies to increase landfill diversion from 35% to 60% by year 2030.



Strive to reach a diversion rate of 60% from landfill by the year 2030



Participate in the reduction, reuse, recycling and composting of additional types and quantities of materials



Rely on business leaders to provide models to pave the way for more organizations to incorporate sustainable practices



Infuse education and outreach with connections to national and international efforts and standards



Work together as a community toward a zero-waste future

Calculating Waste Diversion from Landfill

The formula for calculating waste diversion varies widely among zero waste communities. Discussion is underway nationally to coordinate the tracking and reporting of municipal data. In the meantime, Teton County follows the general formula common for communities of similar size and situation:

$$\text{Waste Diversion From Landfill} = \frac{\text{Amount of Material Diverted (Reused + Recycled + Composted + Hazardous Waste)}}{\text{Amount of Material Diverted + Waste to Energy + Landfilled}}$$

Materials delivered to ISWR facilities that are **included** in waste diversion from landfill totals:

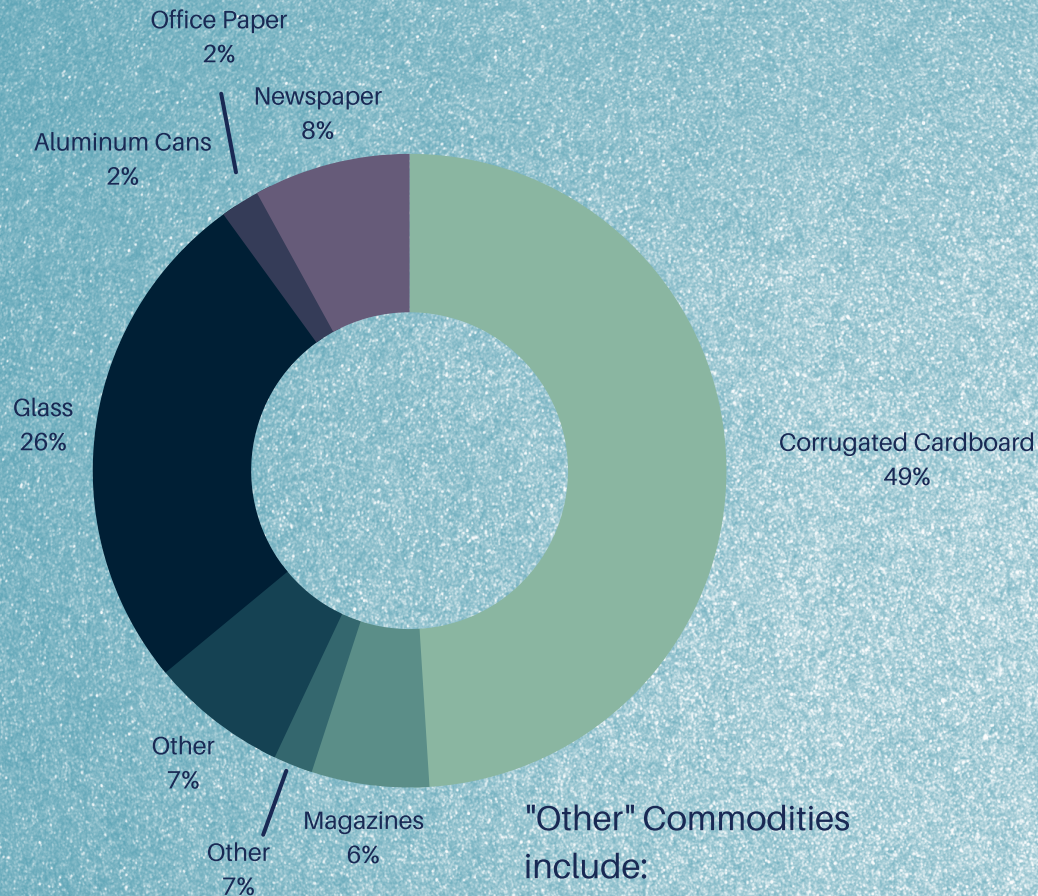
- Recyclables
- Reusables (textiles, books)
- Compostables (yard waste, sod, manure, food waste)
- Household hazardous waste
- Construction and demolition materials (dimensional lumber, wood, concrete)
- Tires
- Mattresses

Materials delivered to ISWR facilities that are **excluded** from waste diversion from landfill:

- Landfill bound discards

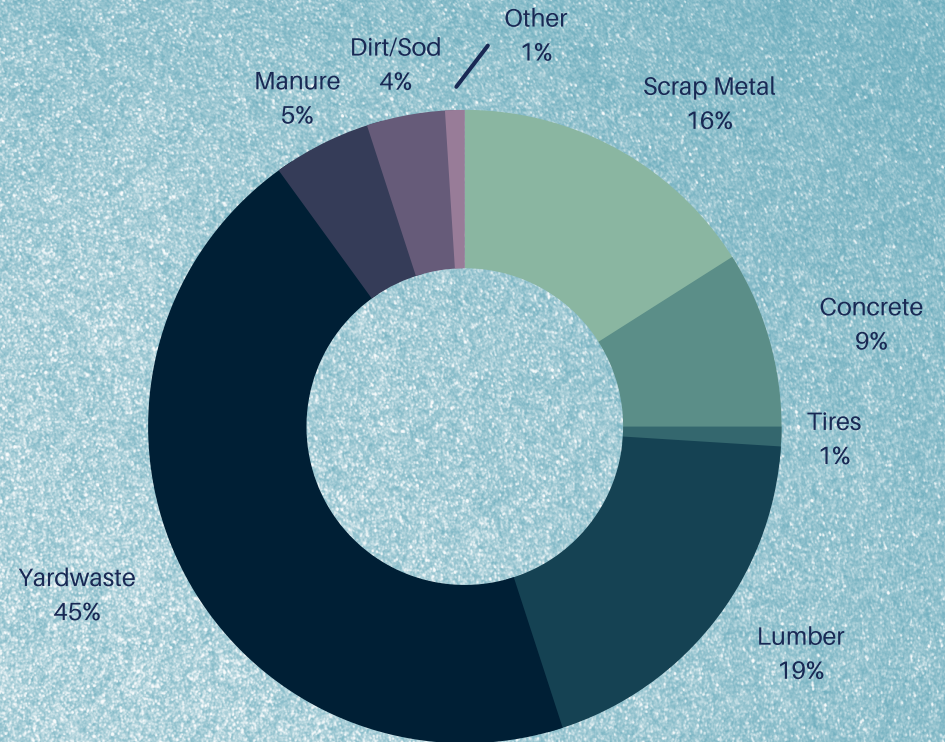

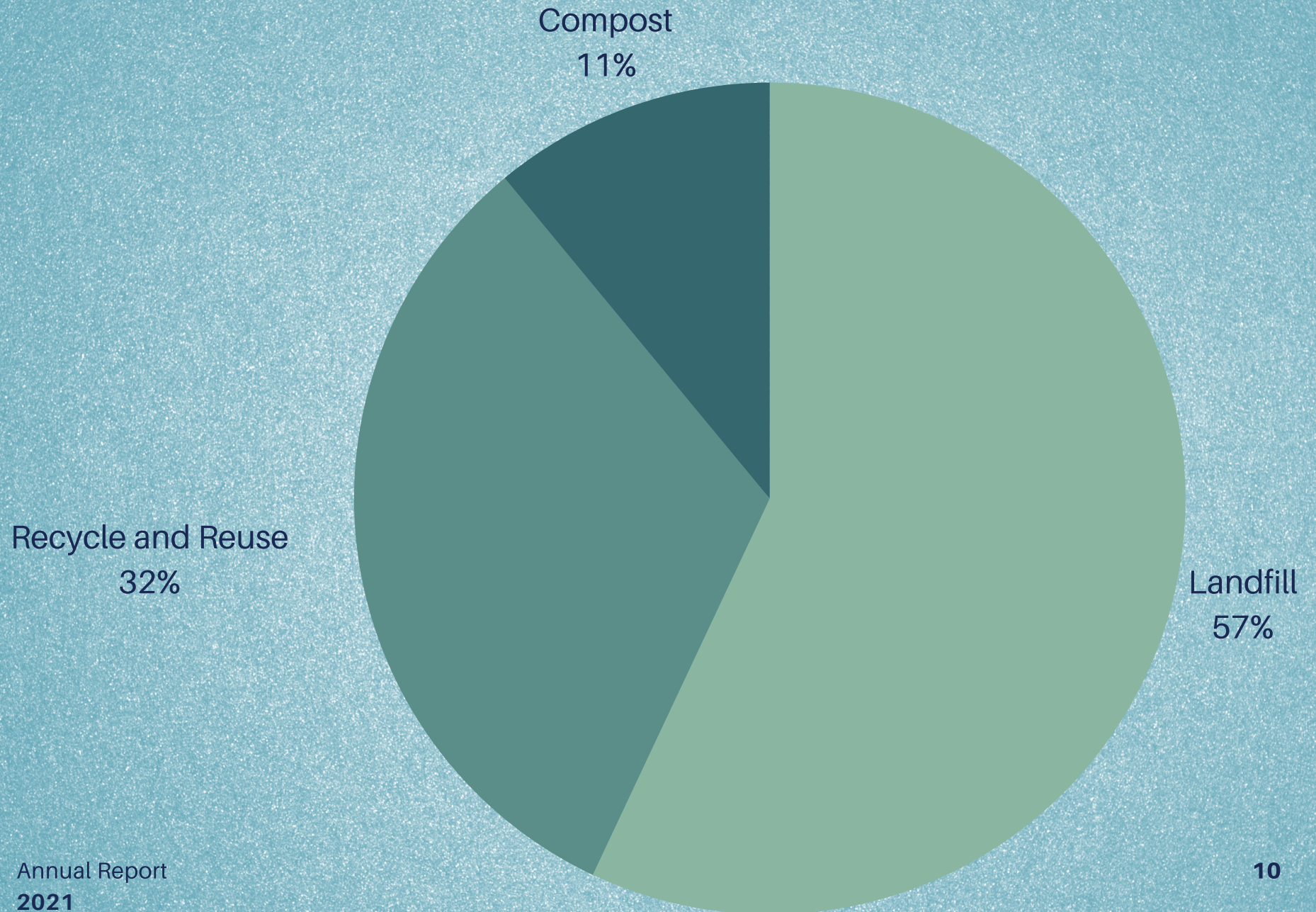
Trash Transfer Station Material Profile

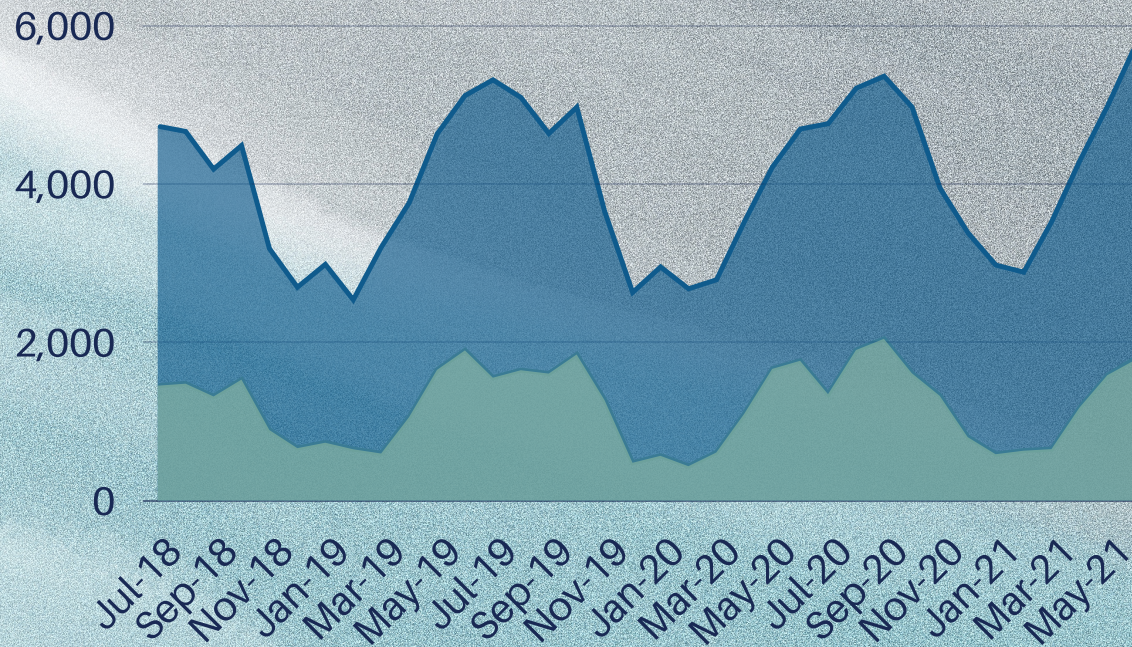

Solid Waste Diversion Profile 2021



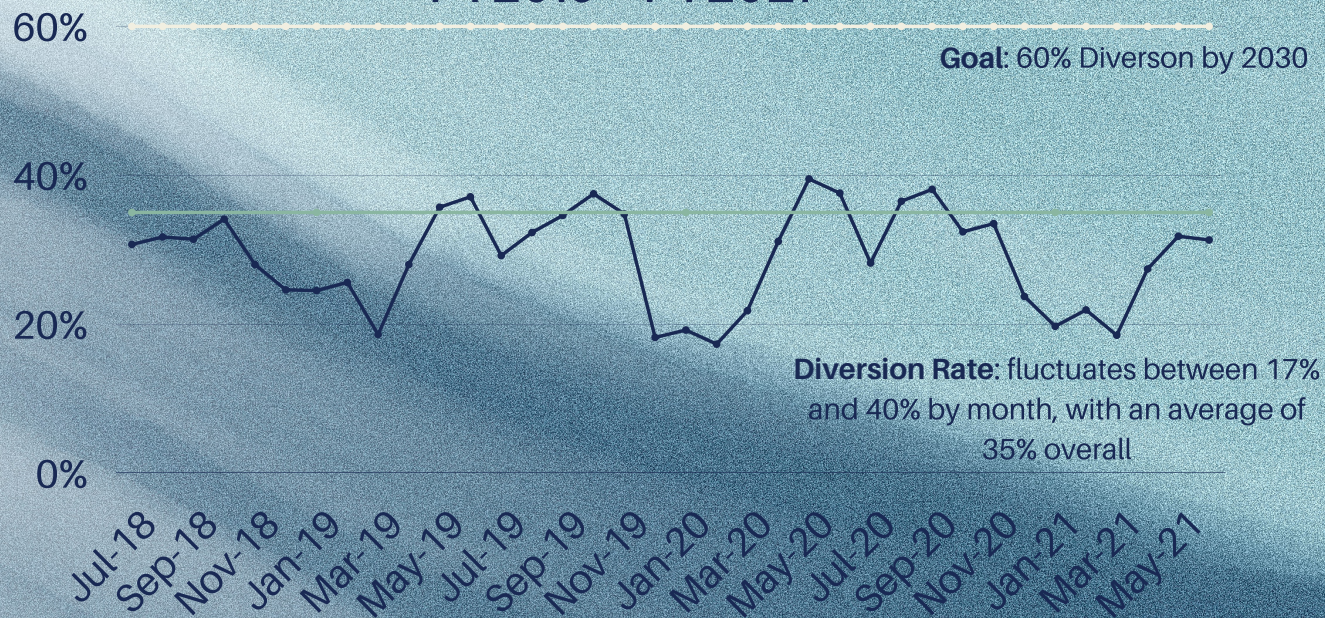
Tons Diverted vs. Tons Landfilled

FY2018 - FY2021



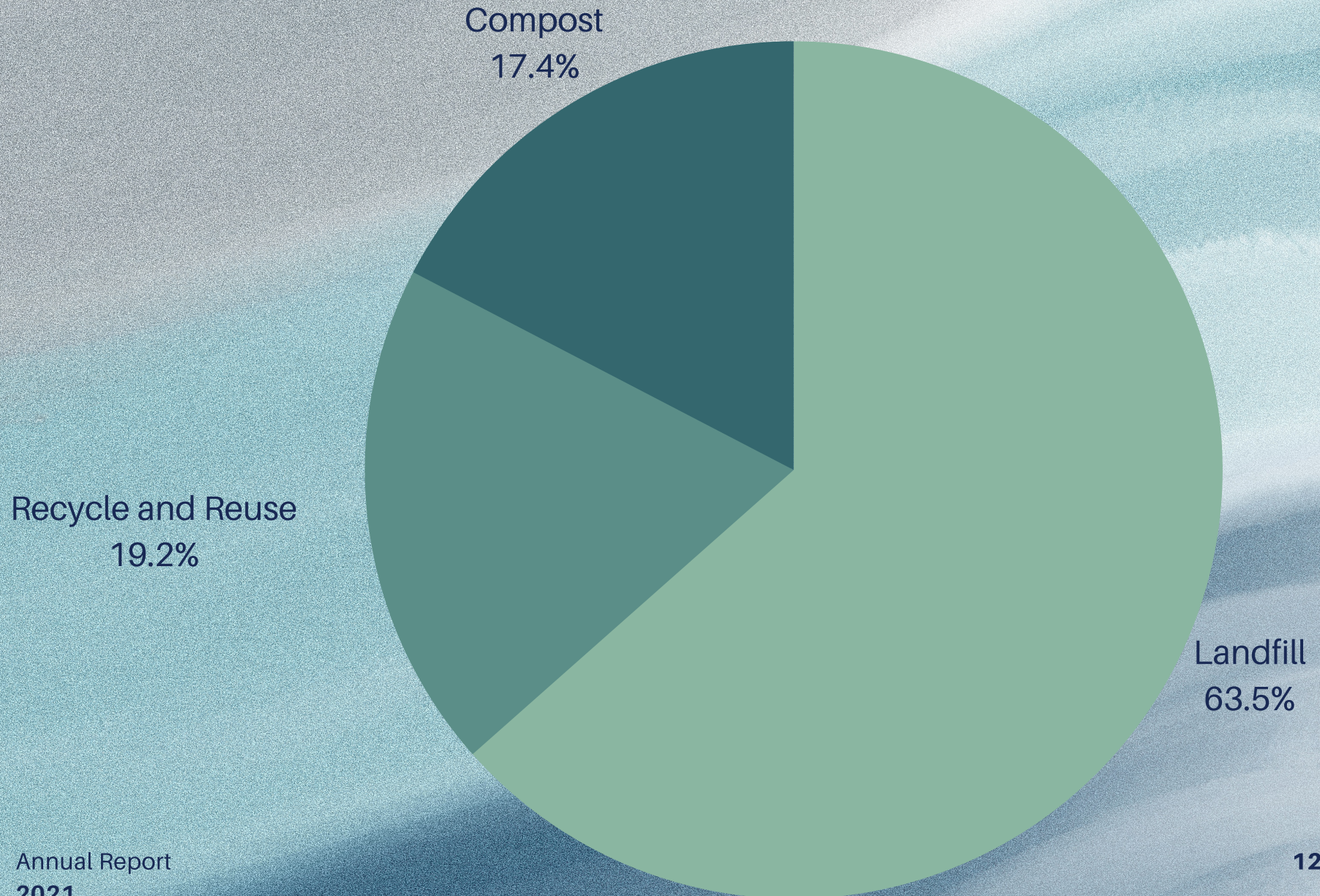
Waste Diversion from Landfill

FY2018 - FY2021



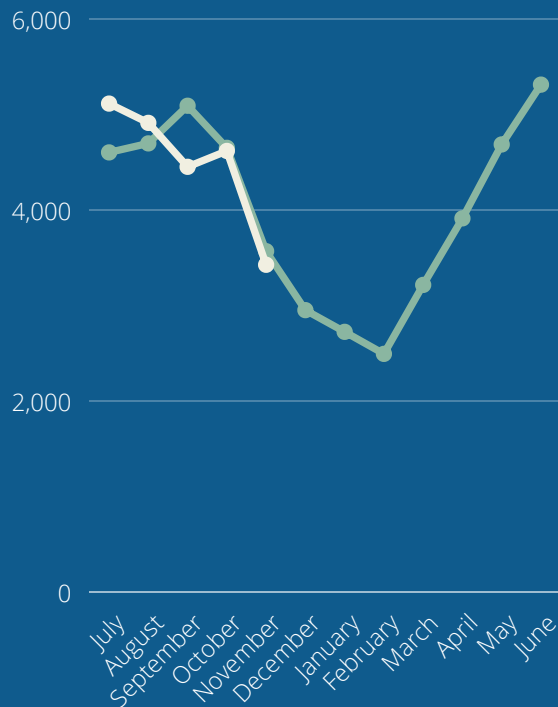
Solid Waste Diversion Profile

FY2018 - FY2021



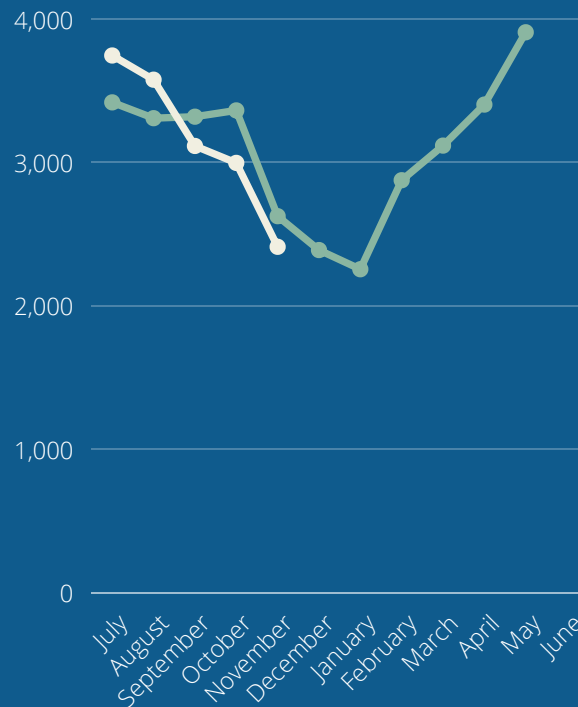
Fiscal Year 2022 Tonnages and Diversion Rate Projections To Date

TTS Tons Inbound



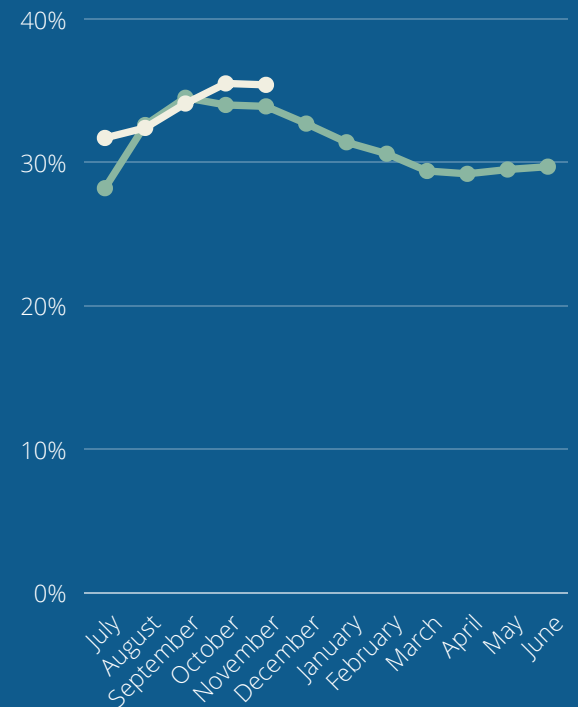
FY2022 trends overall lower tonnages of inbound general waste recieved at the Trash Transfer Station

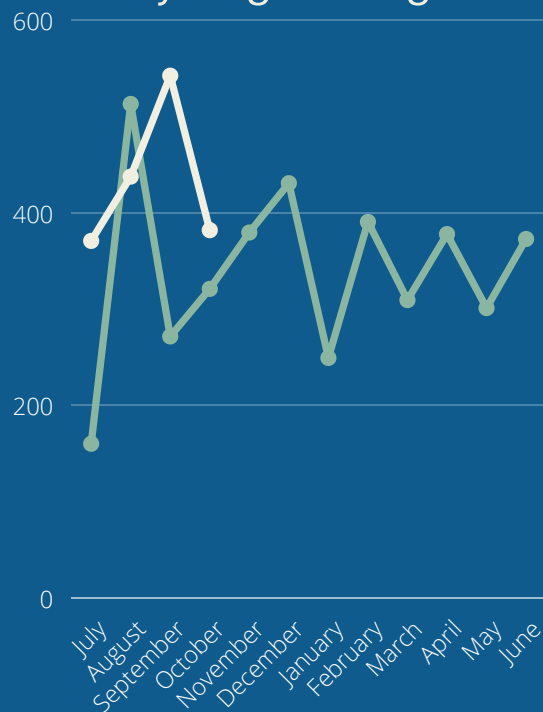


FY2022 trends overall higher tonnages of recyclables, reusables and divertables from general waste at the Trash Transfer Station



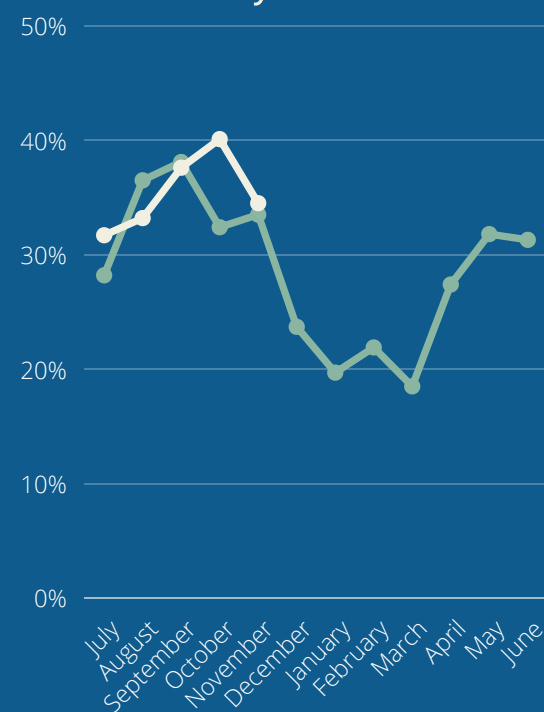
Fiscal Year 2022 Tonnages and Diversion Rates Projections To Date

ISWR Waste Audit 2022

In the past decade, our region has seen increased economic prosperity, which has had effects on public infrastructure provision, construction & demolition activity, and general consumption. Additionally, the diversity of industry and visitor-ship found within the County may have produced changes in Municipal Solid Waste (MSW) composition. Consequently, a MSW Study is now needed.

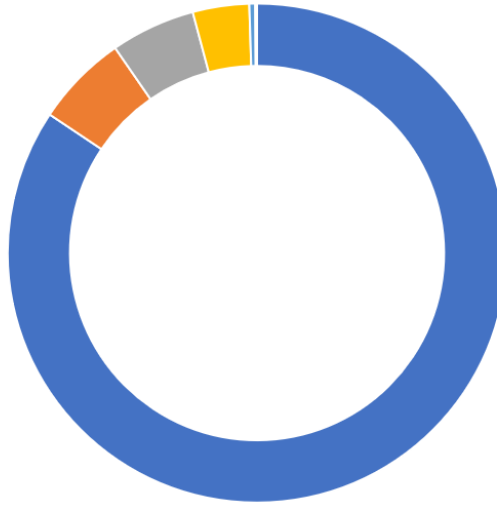
Teton County ISWR has hired a qualified contractor to conduct a comprehensive Waste Characterization Study. The data collected will help inform ISWR on how to improve waste prevention, reuse, recycling, composting and other waste diversion opportunities and enable ISWR to focus its resources where they are most needed to address:

- recyclables in the waste stream
- compostable materials in the waste stream
- banned materials in the waste stream
- opportunities for further waste diversion

Administration & Financials

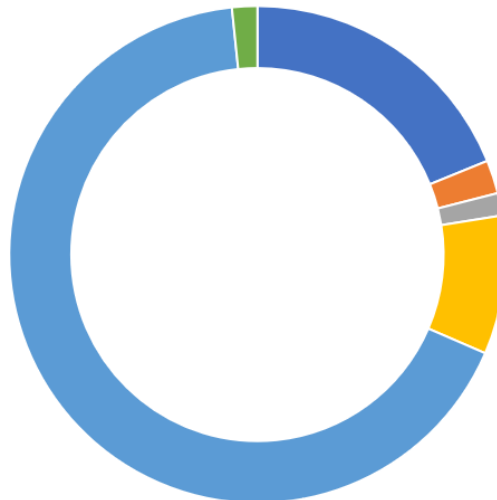

Fiscal Year 2021 Revenue



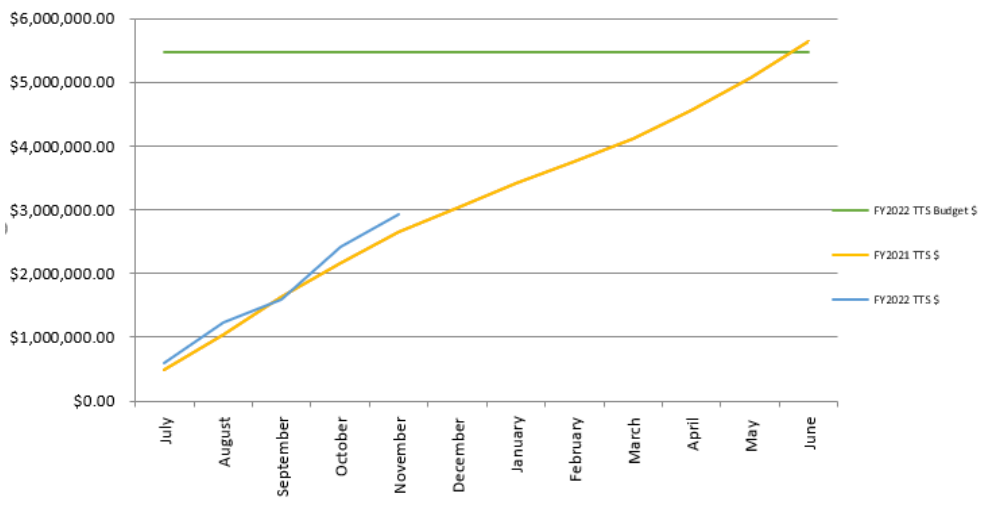

Fiscal Year 2021 Expenses

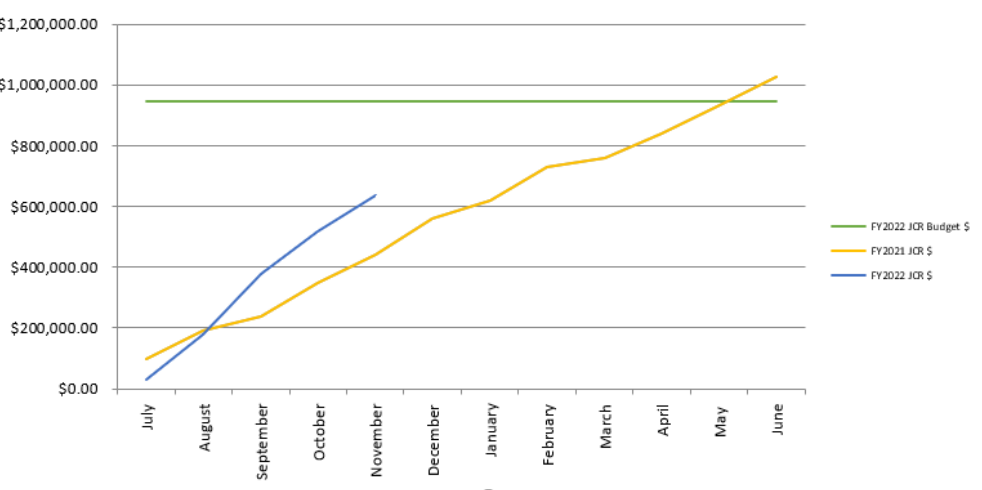
