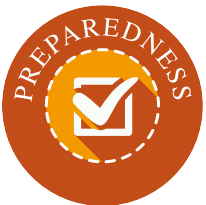


Community Prevention

The Community Prevention Program promotes evidence-based strategies, education, outreach, and trainings to prevent suicide and reduce the problematic use of alcohol, tobacco, and other drugs. The prioritized areas of concern are suicide, tobacco, underage drinking and marijuana use, adult overconsumption, and opioids and other drugs.

Environmental Health

Environmental Health provides public health protection and education through a variety of programs. In addition to routine inspections of food establishments, recreational water facilities, and body art establishments and practitioners, Environmental Health is focused on educating the community by providing classes and educational materials. Classes provided by the Division include pool operator training and food safety manager training. Environmental Health also acts as a resource for drinking water quality, indoor air quality, lead poisoning, radon testing, and other general environmental health hazards.

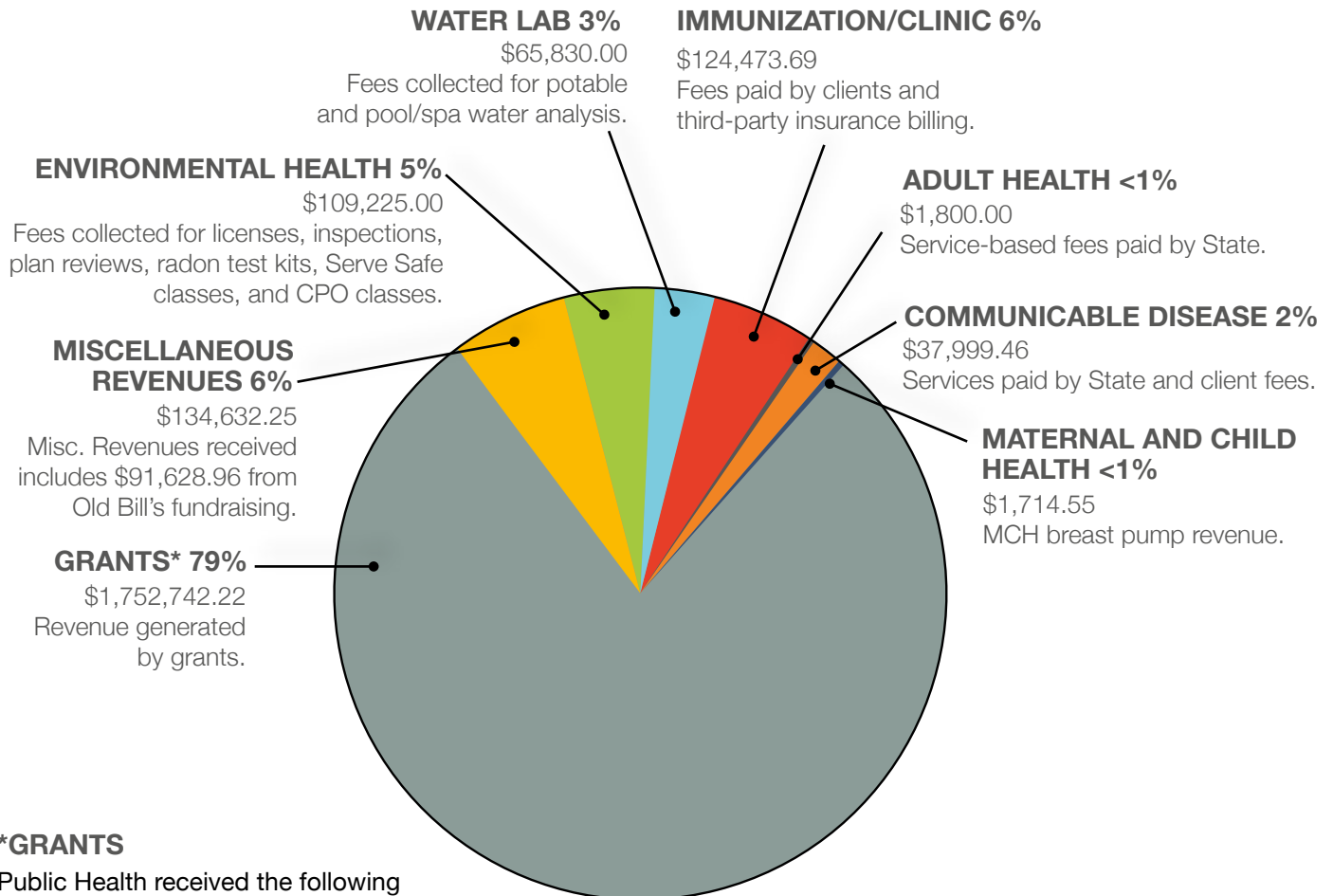

FINANCIALS

INCOME:

The overall revenue, including grants, was \$2,228,417.17 this Fiscal Year. This represents a decrease from the previous Fiscal Year and is attributed to reduced COVID-19 Grand revenue. Other general revenue from services increased, partially offsetting this loss.

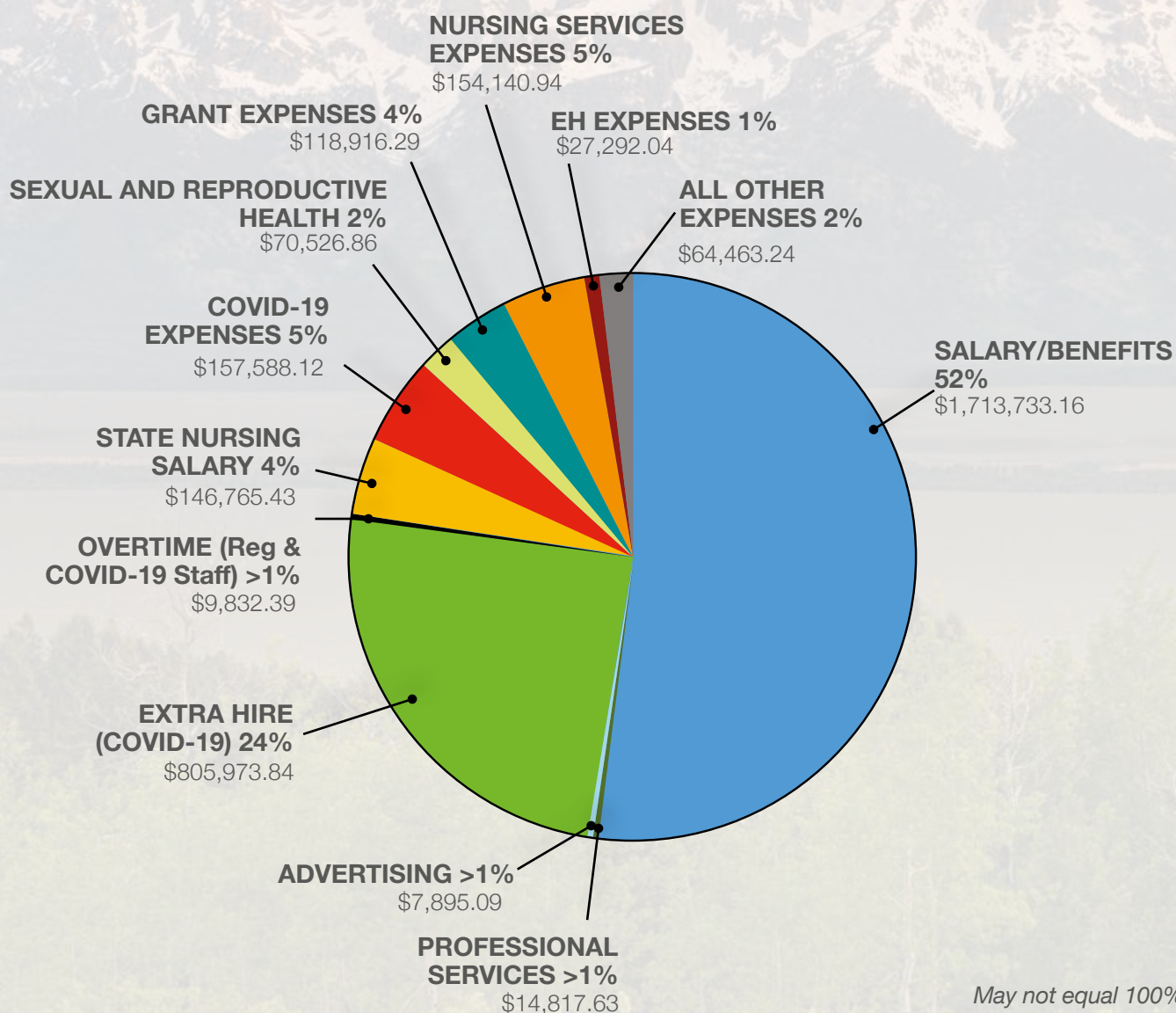

FINANCIALS

EXPENSES:

The overall expenses this Fiscal Year were \$3,291,945.03. This represented a decrease from last Fiscal Year of \$1,302,198.79. The majority of this decrease is reflected in the decrease of expenses related to COVID-19 (Extra Hire Salaries/Benefits, Overtime, and Supplies), while most other expense categories increased slightly from the last Fiscal Year due to returning to full services. All COVID-19 expenses were reimbursed through federal grant funding or donations from the Community Foundation of Jackson Hole.

COMMUNITY OUTREACH

Community Prevention Program:

- Drug Take Back Program – 103 pounds of expired and unused prescription medicine collected and safely disposed of during two Drug Take Back Days
- Prevention and Wellbeing Party in the Park event focusing on community alternatives to alcohol
- safeTALK – Suicide Alertness for Everyone training, 32 community members participated, as well as a training day with Grand Teton National Park employees and interns
- Crisis Intervention Training (CIT) – 38 law enforcement officers completed 40 hours of training
- Training for Intervention Procedures (TiPS) – 86 servers certified at eight Responsible Alcohol Server Trainings earned a certification
- Mental Health First Aid – Taught to 28 adult community members
- Too Good For Drugs – 990 4th - 12th graders received prevention curricula, consisting of mitigating risk factors and enhancing protective factors related to tobacco, alcohol, marijuana, opioids, and other drug use
- Booth at People's Market to promote community prevention services relating to suicide, tobacco, alcohol, marijuana, opioids, and other drug use

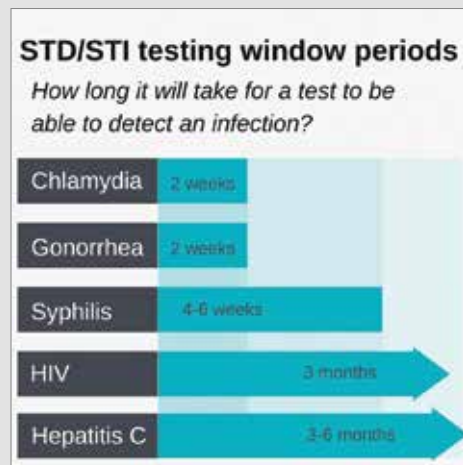
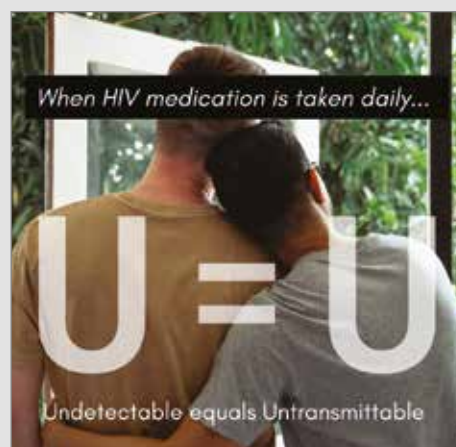

Sexual and Reproductive Health:

- Pride STI testing event – 19 people tested and provided with additional safe sex materials and information
- Welcome to Jackson Hole, a workforce resource event. Provided information on sexual and reproductive health resources, local, and national mental health needs
- Sexual health, STIs, and birth control method classes offered to all local high schools. 255 students received direct instruction from health department staff and nurses
- Parks and Recreation event providing information on sexual and reproductive health services at Teton County Health Department
- Jackson Lake Lodge employee event providing local health resources including Teton County Health Department services
- Prom Dress Rugby providing information on sexual and reproductive health services and advertising free Pride testing event

Other Outreach:

- Grand Teton National Park event providing resources on sexual and reproductive health, COVID-19, and community prevention
- Two lead screening events testing 41 children for lead and hemoglobin levels



- Senior Flu Clinics at the Senior Center of Jackson Hole providing 259 flu shots
- Other Outlying Flu Clinics include the Teton County School District and one mobile clinic day going around the community

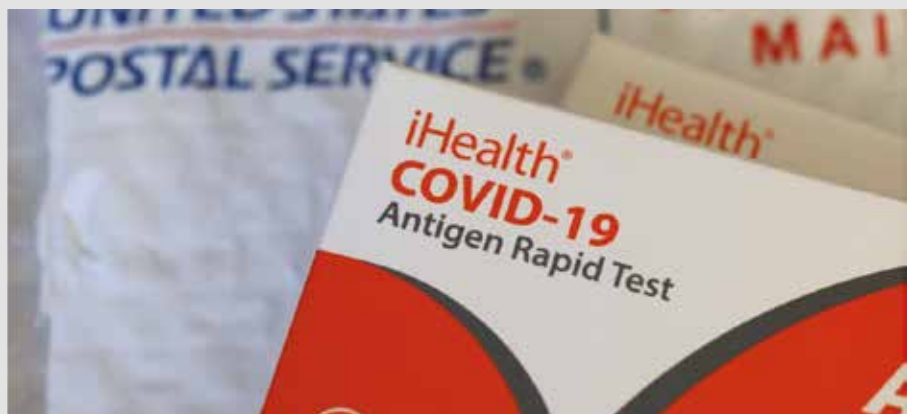


COVID-19 response

COVID-19 Response Focused on 6 Areas:

- Business Liaison
- Epidemiology
- Isolate and Trace
- Public Information
- Statistics
- Testing and Triage
- Vaccination

The COVID-19 division was built to help serve the entire community in Teton County including its workforce, residents, visitors, and commuters. Specific focus was made on those at the greatest risk for severe COVID-19 disease including those over 65, non-native English speakers, uninsured individuals, and underinsured individuals. The COVID-19 team worked with community organizations that serve these groups to make sure information on testing, vaccine, isolation, quarantine, treatment, and more were up to date.



In this Fiscal Year we were able to reduce our COVID-19 response staff since the throughput at our COVID-19 vaccine clinics was more manageable and the calls received at the COVID-19 Hotline decreased. In Fiscal Year '21 - '22 we hired 20 employees; 44 employees ended their employment on the response team. We maintained a core group of 16 response employees and four contracted individuals.

Our 2022 NACo (National Association of Counties) Achievement Award highlighted and thanked the countless volunteers who dedicated their time to helping throughout our COVID-19 efforts.

Teton County COVID-19 Hotline

A call center was established to answer questions from the community beginning January 2020 through May 2021 and August 2021 through February 2022. A total of 133 volunteers worked 2,064 hours answering calls and supporting our community members. During the Omicron surge in December 2021 and January 2022, the hotline was receiving between 150 - 200 calls daily.

Response

Case Investigation:

- A total of 9,073 cases occurred and were investigated from July 1, 2021 – June 30, 2022.

COVID-19 Vaccinations:

The START Bus donated a small bus for COVID-19 vaccine outreach around the community.

- 16,491 doses of COVID-19 vaccines were administered by the Health Department from July 1, 2021 – June 30, 2022.
- 3,338 doses of COVID-19 vaccines were administered by the Health Department from July 1, 2021 – June 30, 2022, for those under 18 years old.
- 400+ COVID-19 Vaccine doses given at 75 community-based events with 35 different community partners (non-profits, businesses, and agencies).
- 720 children ages 5 - 11 years old were vaccinated in November and December 2021 when the COVID-19 vaccine for that age group was initially authorized under emergency use.



Teton County COVID-19 Dashboard:

The Dashboard provides information and statistics on COVID-19 for Teton County, Wyoming. The Dashboard is updated each business day by our local epidemiologist and provides statistics regarding how many community members are fully vaccinated, the current case rate, COVID-19 inpatients at the hospital, and other important metrics.

Testing:

In November 2021, Teton County Health Department was able to add a rapid PCR COVID-19 testing location run by Curative, Inc. This rapid testing center became an additional resource to the community to access no-cost COVID-19 testing thanks to a partnership with St. John's Health, the Wyoming Department of Health, and Teton County.

Volunteers at the Vaccine Clinics:

Since the COVID-19 vaccination effort began in the winter of 2021, a total of 57 administrative volunteers covered 387 shifts, working a total of 1,548 hours. 365 volunteer vaccinators worked a total of 7,918 hours.

Team Rubicon and its volunteers assisted at the COVID-19 vaccine clinics from Spring 2021 through December 2021. A total of 170 volunteers worked 921 shifts totaling 4,136.5 hours.

HEALTH DEPARTMENT STATS

COMMUNITY PREVENTION COALITION OF TETON COUNTY:

The CPCTC utilizes effective prevention strategies that strengthen community efforts to prevent suicide and reduce the problematic use of alcohol, tobacco, and other drugs. The Coalition is comprised of 14 governmental, non-profit, law enforcement, faith-based, and social service agencies, and is led by TCHD. The Coalition meets monthly to collaborate, communicate, and work with our partners and stakeholders to keep our kids and families safe and supported. CPCTC works to provide evidence-based strategies and programming through a diverse community prevention work plan.

SUICIDE PREVENTION SUBCOMMITTEE:

Is a subset of the CPCTC and is comprised of nine different community agencies and led by TCHD. The subcommittee meets monthly to understand issues concerning suicide and mental health as a way to take part in suicide prevention, help others in crisis, and change the conversation surrounding suicide.

EMERGENCY PREPAREDNESS & RESPONSE



- The Public Health Response Coordinator (PHRC) continued to manage the COVID-19 Response in Teton County. The COVID-19 response was used to fulfill the public health preparedness and response program deliverables again this Fiscal Year. TCHD operated under an incident command structure during the COVID-19 response.
- 100% of staff are fit tested for N95 masks
- The PHRC worked with the Wyoming Department of Health (WDH) to order Strategic National Stockpile supplies, such as N95 masks, surgical masks, and COVID-19 testing supplies. Using criteria set by the WDH for testing supplies, local organizations that qualified were notified and supplies were then distributed.

ENVIRONMENTAL HEALTH

FOOD SERVICE INSPECTION PROGRAM:

- 395 Routine Inspections, 213 Follow-Ups, and 137 Other Inspections are conducted
- 40 new food service licenses were issued
- 13 Plan Reviews were completed
- There are 369 food establishments in Teton County. 163 establishments are categorized as high risk, 120 as medium risk, and 86 low risk.

Low risk – The establishment's operation involves coffee, carbonated beverages, and snack items such as a convenience or retail store. One routine inspection and one telephone inquiry annually.

Medium risk – Establishment has limited menu with minimal preparation of items that are cooked to order such as a sandwich shop or fast food. One routine inspection and one telephone inquiry annually.

High risk – Full service establishment where preparation process includes cooking, cooling, and holding or food is served to a high-risk population. These include schools, restaurants, and grocery stores. Two full inspections annually.



- The most common critical food violation was a failure to datemark ready-to-eat refrigerated food; the second most common was the improper cold holding of refrigerated foods.
- 193 Temporary Food Permits were issued

ENVIRONMENTAL HEALTH

POOL/SPA INSPECTION PROGRAM:

- There are 137 pools and spas in Teton County. Seasonal facilities require one inspection per year; year-round facilities require two inspections per year.
- 140 Routine Inspections, 88 Follow-Ups, and 9 Other Inspections were conducted
- 17 New pool and spa licenses were issued
- The most common pool and spa critical violations were record keeping and meeting minimum testing frequencies, followed by pool or spa water quality, usually having to do with sanitizer levels
- 5 Plan Reviews were completed

BODY ART ESTABLISHMENT INSPECTIONS PROGRAM:

- There are five body art establishments and five practitioners in Teton County. Body Art Establishments and Practitioners need to be inspected yearly

RADON PROGRAM:

- 164 radon test kits were distributed. 113 results were reported back. 44 out of 113 test results (39%) were above the EPA action level (4.0 pCi/L)

POOL/SPA/FOOD CLASSES:



- Three Certified Pool Operator courses were offered with 36 participants earning certification.
- No Food Manager Safety Courses were offered due to COVID-19. Online options were available and encouraged. Proctoring sessions were increased to twice a month to accommodate those who needed proctoring.

WATER TESTING PROGRAM:

- There were 2,201 drinking water samples tested. 145 tested positive for Total Coliform, and 24 tested positive for E.coli.
- There were 1,088 pool/spa water samples tested. 54 exceeded the bacteria threshold limit.



NURSING & CLINICAL SERVICES

COMMUNICABLE DISEASE PROGRAM:

- 1,043 Counseling and Testing visits (353 through Sexual and Reproductive Health)
- 90 STI treatments
- 537 HIV tests conducted
- HIV Case Management: 13 cases
- PrEP Case Management: 19 cases



The Teton County Health Department introduced a case management model for PrEP services this fiscal year. Each person enrolled in the PrEP program had one nurse case manager who managed the client's prescriptions, appointments, and financial assistance applications. Each PrEP client requires an annual visit with a nurse practitioner, STI/HIV testing every 3 months, a new prescription every 3 months, and labs to monitor kidney function at least once per year. Some clients also require assistance with monthly medication delivery and applications for financial aid to access the medication. Teton County Health Department has collaborated with other county public health offices to facilitate testing for clients who don't live in Teton County but are enrolled in the TCHD PrEP program due to prescriber availability. Assistance was also provided to clients by case managers to help them establish PrEP care when they left Teton County. PrEP is an HIV prevention method where people who don't have HIV take daily medication to reduce their risk of getting HIV if they were exposed.

- PEP: 2 Cases referred for PEP (Post-exposure to HIV prophylaxis) treatment

SEXUAL AND REPRODUCTIVE HEALTH:

Teton County Sexual and Reproductive Health (SRH), formerly known as Family Planning, has continued to provide birth control, Well-Woman exams, and reproductive and sexual health care throughout the pandemic, with a steadily increasing number of clients.



- 2,047 in-person, phone, or telehealth appointments with Family Nurse Practitioners (FNPs) and clinic staff.
- Long-Acting Removable Contraceptives (LARCs)
 - 46 IUDs provided and/or inserted onsite
 - 35 Implants provided and/or inserted onsite

- CANCER PREVENTION: Clinic FNPs ordered 200 PAPs, 89 mammograms, 11 colonoscopies; 13 PAPs were abnormal and required further evaluation and/or follow-up

- PREGNANCY: 197 focused discussions and/or tests conducted

- MENTAL HEALTH: Limited funds were made available for clients to access mental health services during the past Fiscal Year through the Communicable Disease Grant. 49 referrals were made to the counseling fund and 37 people accessed care. The funds were expended, and additional funds were obtained beginning August 2022 on behalf of donations from St. John's Health Foundation, the Community Foundation of Jackson Hole, and private donors.

- REFERRALS/APPLICATIONS:

- 71 referrals to local providers for follow-up care
- 179 clients assisted with applications to St. John's Health Foundation Women's Health Care Fund, WY Cancer Care, Bayer, Merck, Gilead, and others

NURSING & CLINICAL SERVICES



IMMUNIZATIONS PROGRAM:

- 1,205 vaccines other than COVID-19 vaccines and flu vaccines were given to those 18+
- 715 vaccines other than COVID-19 vaccines and flu vaccines were given to those under 18 years old
- 2,143 doses of flu vaccine were given. Of the total doses, 1,525 regular flu vaccines were given to adults 18+ and 618 high-dose flu vaccines were given to adults 65+
- 267 Flu vaccines were given to those under 18 years old

MEDICATION DONATION PROGRAM:

- From July 1, 2021, to June 30, 2022, Teton County donated \$1,244.29 of usable inventory

MATERNAL AND CHILD HEALTH (MCH) PROGRAM:

MCH nurses work to improve Maternal Mental Health in our community and statewide through programs such as Postpartum Support International (PSI) Wyoming, Stroll Wyoming, and the 2020 Mom Maternal Mental Health Public Health Fellowship.

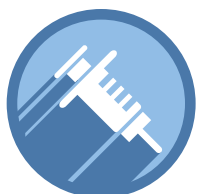


- 576 total MCH visits for the year
- 177 clients served
- 329 visits assisting clients with financial assistance applications
- 56 Children's Special Health appointments
- 73 appointments for other services including child safety education, car seat installations, and lactation for non-home visiting clients
- 613 visits required an interpreter. These were mostly MCH visits, but also include Sexual and Reproductive Health and Immunization appointments
- 17 Strollers given out through Stroll Wyoming

Stroll Wyoming is a program created by one of our MCH nurses. The program provides strollers to mothers and families who may not otherwise have access to them. The hope is that through the gift of a stroller, these families can more easily access our beautiful outdoor trails and pathways, thereby improving their mental health and quality of life. In addition, the hope is to bring together the stroller recipients in a group setting to foster connection between new moms.

OUTBREAK INVESTIGATION:

- 44 cases of rabies concern follow-up (43 bats and 1 racoon)



SHARPS DISPOSAL PROGRAM:

- Collected 26 total containers and 1,075 pounds of sharps. The increase in sharps disposal was due to the increased number of COVID-19 vaccines administered.

SEXUAL HEALTH OUTREACH ACTIVITIES AND EDUCATION:

- Sexual Health, STIs, and birth control method classes
 - JHHS Fall and Spring semester: 220 Students
 - Summit High School: 10 Students
 - Mountain Academy: 25 Students
- Creation of the Transgender Access to Care Guide: A list of local providers and resources for those seeking gender-affirming care
- Grindr sexual health resources profile created and monitored
- 74,129 Condoms distributed to 10+ locations
- Two gender-inclusivity sessions totaling 3 hours of instructions
- Intake paperwork revised to appropriately support gender diverse clients and Spanish speaking population
