**2025 Fee Schedule for the Jackson Hole Fire/EMS Department  
(Applicability-Unincorporated Areas of Teton County outside of the Town  
of Jackson)  
Effective Date January 1, 2026**

**WHEREAS**, Teton County is authorized by Wyoming State Statute §35-9-121 to enforce and interpret local or state fire codes; and

**WHEREAS**, the Teton County Board of County Commissioners has adopted the 2024 Fire Code Resolution that applies to the unincorporated lands within Teton County; and

**WHEREAS**, through the 2024 Fire Code Resolution, the Teton County Board of County Commissioners has adopted the 2024 Edition of the International Fire Code, and the 2024 International Wildland Urban Interface Code; and


**WHEREAS**, Section 107.2 of the 2024 International Fire Code, the governing authority, the Board of County Commissioners, may adopt fees to implement the fire code.

**NOW THEREFORE**, having met at a regular meeting on, and having fully considered the matter, it is hereby,

**RESOLVED**, that the Teton County Board of County Commissioners approves and adopts the following fee schedule which shall be in effect as of January 1, 2026, outside of the City of Jackson in the unincorporated area of Teton County; and



\$501.00 – \$2,000.00	\$40 for first \$500 plus \$2.00 per \$100 over \$500
\$2,001.00 – \$25,000.00	\$70.00 for first \$2,000 plus \$15.00 per \$1,000 over \$2,000
\$25,001.00 – \$50,000.00	\$415.00 for first \$25,000 plus \$11.00 per \$1,000 over \$25,000
\$50,001.00 – \$100,000.00	\$690.00 for first \$50,000 plus \$8.00 per \$1,000 over \$50,000
\$100,001.00 – \$500,000.00	\$1,090.00 for first \$100,000 plus \$6.00 per \$1,000 over \$100,000
\$500,001.00 – \$1,000,000.00	\$3,490.00 for first \$500,000 plus \$5.00 per \$1,000 over \$500,000
Over \$1,000,000.00	\$5,990.00 for first \$1,000,000 plus \$4.00 per \$1,000 over \$1,000,000
