Board of Commissioners Action Summary

This section summarizes major actions taken by the Teton County Board of Commissioners. The Agenda Center on the County's website contains meeting minutes for a more detailed record of discussions and decisions.

- At the Regular Meeting on April 10, 2018, the Board of Commissioners approved a Cooperative Agreement with the Wyoming Department of Transportation for Tribal Trails Road. This project will require the development of a "Project Charter", which will guide the planning and process, including public outreach and input opportunities. - Other various items and contracts were approved throughout April. Following every Regular Meeting, a Teton County Board of Commissioners "Action Report" is created, posted, and distributed electronically.

Engage2017 Update

The Engage2017 planning process continues its fourth and final phase, working towards policy updates for Housing Rules & Regulations, Housing Requirements, Town Zoning & Parking, and Natural Resource Protections.

In April, the following meetings, events, and opportunities for public input took place:

- April 12 – All day Public Open House for Housing Requirements and Town Zoning & Parking
- April 19 – Elected officials review of Housing Mitigation Requirements and Town Zoning
- April 20 – Affordable Housing Department release of final draft of Housing Rules & Regulations
- April 23 – Town Zoning Update at Town Hall
- April 24 – Housing Mitigation Requirements Update at the County Administration Building

County Construction Projects

Construction season has arrived. As Teton County and other partners around the region begin major projects, please stay informed and plan accordingly:

Teton County projects:

- Cattleman's Bridge – WYDOT's goal for project completion was originally set as October of 2017, but the bridge is now expected to be completed in early to mid-Summer. More detailed information can be accessed at www.tetoncountywy.gov/1679/Cattlemans-Bridge. The bridge is currently open to one-way, alternating, signal-controlled traffic.
- Targhee Towne Road – Targhee Towne Road will be under construction from Monday, April 30, to Friday, May 25, for paving. Work will take place from 7:00am-6:00pm, Monday through Saturday. Traffic control workers will manage traffic during this time. Call Teton County Road & Levee for additional information (307-733- 7190).
